## GUARANTEE CONTRACT

We jointly and severally GUARANTEE on behalf of ourselves the due repayment to you by Mr. / Mrs. Avi Cohen  
of said sum by monthly payments of £ 100 starting on Day 01 Month 08 Year 2010.  
We jointly and severally undertake on behalf of ourselves that if at any time he/she shall make default in two consecutive  
monthly payments, we will on demand pay you the amount of the arrears for the time being. We further jointly and  
severally undertake that if after the first occasion the arrears of the said Mr. / Mrs. Avi Cohen shall be  
paid by ourselves, he/she thereafter makes further default in any further instalment, we will, on demand, pay the whole  
amount remaining unpaid of the said loan.
- We further jointly and severally agree on behalf of ourselves that this shall be a continuing guarantee, and that you shall  
be at liberty to give time for the payment of the whole or any part of the debt from time to time to Mr./Mrs. Cohen  
or to grant any other indulgences to Mr./Mrs. Avi Cohen without asking for our or any of our consents and  
that such giving of time or any other indulgences shall not exonerate us or any of us from our joint and several liability  
under this guarantee.

  - That any claim or cause arising between us hereunder shall be referred to the arbitration of the Beth Din  
(Court) of the Union of Orthodox Hebrew Congregations according to the rules of procedure established  
for and customarily employed in reference to arbitration before the said Beth Din.
  - That after the parties hereto or any of them shall have been heard at the first hearing this reference may  
continue ex-parte in case any party hereto fail after reasonable notice to attend any subsequent hearing or  
hearings.
